Subject: About "Swayam" Project Evaluation Study

Government of Maharashtra has approved "Swayam" Project for the period 2017-18 to 2019-20 vide Government Resolution No. Poultry-2017 Pra.Kra. 271/Padum-4, Dated: 29 April 2017 (Department of Agriculture, Animal Husbandry, Dairy Development and Fisheries).

This Government Resolution pertains the need for balanced diet of the families in the Scheduled Areas of the State, implementation of other schemes related to Poultry and Animal Husbandry in those areas as well as to create self-employment and to implement a comprehensive integrated scheme to increase the financial income of the family providing employment to tribal families in the state through poultry farming, supplying eggs through Anganwadis.

"Swayam Project" is being implemented by Animal Husbandry Department in 16 districts in the tribal sub-plan area of Maharashtra state. These include Thane, Palghar, Raigad, Pune, Nashik, Ahmednagar, Nandurbar, Jalgaon, Dhule, Amravati, Yavatmal, Nagpur, Gadchiroli, Gondia, Chandrapur and Nanded districts.

To take up evaluation study "Swayam" project, proposals are being invited from the institutions which are empanelled under the category commercial entity Group - 1, Type - 1 (Category A-1) in the Government Resolution issued by the Planning Department Government of Maharashtra, dated September 26, 2017.

The aspirants among the above mentioned Empanelled Commercial entity Group - 1, Type - 1 (Category A-1) are being invited with exhaustive evaluation proposal with details including Manpower available at empanelled institutions, necessary equipment, aggregate funds required for evaluation and time required for evaluation etc.
